Internet Registration

All registration periods. To register on the Internet, your registration must be completed by 5:00 p.m. eastern time on the registration deadline for the period.

Emergency registration period only. To register by telephone, call (413) 256-2896, 9:00 a.m. to 5:00 p.m. eastern time, Monday–Friday, excluding the September 7, 2009, holiday. Emergency registration ends at 5:00 p.m. eastern time on the last day of the emergency registration period.
